COVID-19 NOTICE AND RELEASE**

All members and participants of in-person worship, meetings, events and/or programs held at the Ewing-Covenant Presbyterian Church or Church property will be required to sign a Release and covenant before attending. This Notice and Release need only be signed one time and a record will be kept on file of all who have signed. The Notice and Release will be available at the check-in table for those who have not read and signed the Release. All members and participants shall sign this Notice and Release before participation in any in-person worship, meetings, events or programs.

**Release and Disclaimer for All Attending Worship, Meetings, Events and/or
Programs at the Ewing-Covenant Presbyterian Church**

We are all blessed to be able to use the church facilities for worship, meetings, events and/or programs. We recognize that COVID-19 will require everyone to follow Federal, State and local government guidelines in order to use the facilities. Persons using the facilities of the Ewing-Covenant Presbyterian Church are required to read and sign this Release before participating in any in person activities. This is a one-time signature, covering all programs and events that the participant attends. We hope and pray that the building can be used in a safe and responsible way to the benefit of all. In order for children under the age of eighteen (18) to participate, Parents or Guardians are required to sign this Release on the child's behalf and are responsible for seeing that each child follows the guidelines required by the church for participation.

The Covenant and Release

I, (NAME) _____ am aware of the potential spread of COVID-19 through in-person contact with other individuals and that COVID-19 could result in severe illness or death, and that my actions may affect the health of those around me. I recognize that I am making the personal choice to attend in-person worship, meetings, events and/or programs and do so freely with the understanding that there is the potential to contract COVID-19.

Therefore, I will, to the best of my ability, practice proper social distancing while in the building as recommended by Federal, State and local governments. This includes wearing a mask at all times. I will not attend any events if I do not feel well. I will practice good hygiene (handwashing, use of hand sanitizer) and be willing to have my temperature taken and fill out a health screening questionnaire upon entering the building.

Should I become ill, I promise to self-report the illness to my group leader or contact one of the pastors or the church office to let the church know of my condition. I will adhere to testing guidelines and work with my own health care providers. Finally, if I am exposed or suspect exposure to the virus, I will self-quarantine and notify my group leader or the church.

Furthermore, I hereby release, hold harmless and forever discharge with prejudice the Ewing Covenant Presbyterian Church, their respective agents, employees, representatives, officers, and leadership from any and all liability and/or claims or potential claims should I be exposed to or become ill from COVID-19 due to my participation in, in-person worship, meetings, programs, events at the Church or any Church owned properties.
